# About BASP

The International Window Cleaning Association (IWCA) awards the Building Access Safety Professional (BASP) designation to individuals who have demonstrated their commitment to the window cleaning and building maintenance industry through their accomplishments in leadership of the industry, continuing commitment to its educational programs and participation in the IWCA and other industry organizations – above and beyond the call of duty.

IWCA's BASP program is designed for the building maintenance executive and/or safety training professional who is dedicated to providing the most current safety training education to their staff, but who does not participate in field work every day. The BASP is a lifetime designation.

The certification program consists of three parts:

- Completing the IWCA Safety Training Certification Program-High Rise Specialist
- Earning at least 100 points through association memberships and other training
- One-time \$400 application fee.

By earning the BASP designation, an individual reaffirms his or her commitment to the importance of proper safety and training for those working within the window cleaning and exterior building maintenance fields.

## IWCA Safety Certification

This program consists of three online exams to help prepare you for the final proctored exam. After successfully passing all three online exams with a score of 90 percent or higher, candidates will be qualified to take the final exam.

We recommend candidates attend a classroom review session in conjunction with the regional safety training sessions followed by the proctored exam. Once the candidate passes the final proctored exam, he or she will be recognized as being IWCA Safety Certified for five years. After that time, the certified window cleaner can continue to renew his or her certification through an online renewal procedure. Candidates may enroll for the IWCA Safety Certification program via the IWCA Web site. The cost for earning the IWCA Safety Certification is \$300 per individual.

### Points Toward Certification

In addition to the successful completion of IWCA Safety Certification, candidates must accumulate a minimum of 100 additional points by providing documented evidence of their expertise and/or involvement in their overall industry. These points may be earned through membership in other industry related organizations and completion of additional safety courses as indicated on the application form.

To qualify, applicant must earn a total of 100 points. The application will be reviewed by the IWCA Safety Director, IWCA Executive Director or designate for final approval.
